

Thank you so much for your valuable time and information meeting with IBA team on 7th April 2020 in your office. We also had a chance to have a meeting with DG SDMA Mr. Salman Shah in his office on 8th April 2020. We also got a chance to study SDMA mobile application. We also met with Mr. Fayaz Ahmed Jatoi, Additional Secretary to CM at Covid19 Operation Center.

Following are the action points agreed with DG SDMA on 8th April 2020.

IBA Team with the support of Sindh Health and S&GA department and other emergency response departments will design and develop an integrated software application platform for decision making. The primary users will be health and emergency response departments of Sindh Government.

Following Areas will be covered in the software applications.

Monitor supplies of medical goods such as PPE, gloves and masks etc. at various hospital and quarantine centers across the province. This app would be helpful to identify shortage of any particular item at any specific location. Data from this app can be used to inform public sector organization & private denors where they should send these items.

IBA team suggested that provide Data Analytics for collected data from various sources and apps can be combined for predictive analysis and data modeling to predict upcoming situation and provide basis to Government agencies to develop future plans accordingly.
